Younger pupils and pupils with complex needs will continue to be helped to clean their hands properly. Skin friendly skin cleaning wipes can be used as an alternative.</p> <p>The school will build hand washing routines into school culture, supported by behaviour expectations set out in the school Behaviour Policy.</p> <p>Pupils arriving at school wearing a face covering are instructed not to touch the front of their face covering during use or when removing them. 		<p>Visitors to the site, such as contractors, local authority employees and health employees are fully briefed on the school's arrangements and follow site guidance on physical distancing and hygiene on or before arrival. Where visits can happen outside of school hours, they will be and a record will be kept of all visitors.</p> <p>Classroom based resources, such as books and games, are used and shared within the classroom only; these are cleaned regularly, along with all frequently touched surfaces. Resources that are shared between classes, such as sports, art and science equipment are cleaned frequently and meticulously and always between classes, or rotated to allow them to be left unused and out of reach for a period of 48 hours (72 hours for plastics) between use by different class groups;</p> <p>Pupils limit the amount of equipment they bring into school each day, to essentials such as book bags, water bottles, fruit pots, lunch bags, hats, coats, books. Pupils and teachers can take books and other shared resources home, although unnecessary sharing is avoided. 		<p>If someone tests positive they should follow the <u>'stay at home: guidance for households with possible or confirmed coronavirus (COVID-19) infection'</u> and must continue to self-isolate for at least 7 days from the onset of their symptoms and then return to school only if they do not have symptoms other than cough or loss of sense of smell/taste. This is because a cough or anosmia can last for several weeks once the infection has gone. Other members of their household should continue self-isolating for the full 10 days.</p>

Managing confirmed COVID-19 cases</p>		<p><input type="checkbox"/> If someone has attended the site tests positive for COVID-19, the local health protection team will be contacted by the school.</p> <p><input type="checkbox"/> The health protection team will provide guidance to support a rapid risk assessment to confirm who has been in close contact with the person during the period they were infectious and ensure they are asked to self-isolate.</p> <p><input type="checkbox"/> Based on the advice from the health protection team, the school will send home those people who have been in close contact with the person who has tested positive, advising them to self-isolate for 10 days since they were last in close contact with that person when they were infectious.
